Notice is hereby given that on Tuesday the 10th day of May, 2022, at the usual polling places in the election precincts of Platte County, Nebraska, an election will be held. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for electing candidates to various offices. Some non-partisan races will not appear on the Primary Election Ballot, as the number of candidates filing does not exceed twice the number of positions to be filled. Some county partisan races will not appear on the Primary Election Ballot, as the number of candidates filing does not exceed the number of candidates to be nominated by that party for that office. These candidates are declared nominated and advance to the November 8, 2022, General Election (SS 32-811).
