**Qualifications of Village Board Members**

1. Registered Voter of Platte County and Village Board Member must live in the Village of Creston.
2. Pay the Filing Fee of 1% of the Elected Officials Salary as of November 30<sup>th</sup> of the year preceding the Election for the office for which the candidate files for. Nebraska State Statue 32-608
4. File a NonPartisan Filing Form with the Platte County Election Commissioner Office by the deadlines:

**Incumbents** (are the current office holder) **not on the Primary Ballot. Filing Date is December 1<sup>st</sup> to July 15<sup>th</sup> prior to the date of the General Election.** No Incumbent who resigns from elective office prior to the expiration of their term shall file for any office after July 15<sup>th</sup> of that election year. Nebraska State Statue 32-606

**Nonincumbents** are those who are currently not an office holder and the **filing date is December 1<sup>st</sup> to August 1<sup>st</sup> prior to the date of the General Election.** Nebraska State Statue 32-606
