Partisan or NonPartisan Elections? Partisan Election

When Election Held? Primary and General

District # 1, 3, 5 & 7 are Elected when the Nebraska Governor is Elected which will be in 2022 and every 4 years after that.

District # 2, 4 & 6 are Elected when the United States President is Elected which will be in 2024 and every 4 years after that.

Qualifications of Platte County Board of Supervisors

1. Registered Voter of Platte County.
2. Need to File a Nebraska Accountability and Disclosure C-1 Form by March 1st deadline for the prior year.
3. File a Partisan Filing Form with the Platte County Election Commissioner Office by the deadlines:

Incumbents are the current office holder and **filing date is December 1st to February 15th prior to the date of the Primary Election.** No Incumbent who resigns from elective office prior to the expiration of their term shall file for any office after February 15th of that election year. Nebraska State Statue 32-606

Nonincumbents are those who are currently not an office holder and the **filing date is December 1st to March 1st prior to the date of the Primary Election.** Nebraska State Statue 32-606

4. Pay the Filing Fee of 1% of the County Supervisor Salary as of November 30th of the year preceding the Election for the office for which the candidate files for. Nebraska State Statue 32-608
