PROCEEDINGS OF THE PLATTE COUNTY BOARD OF SUPERVISORS

Columbus, Nebraska July 6, 2021 Tuesday, A.M.

Pursuant to adjournment the Platte County Board of Supervisors met in session beginning at 9:00 a.m. Diane C. Pinger, County Clerk and Gerald B. Micek, Chairman.

Roll Call and the following members present: Supervisors Liss, Engdahl, Kwapnioski, Pfeifer, Lloyd, Scow and Chairman Micek

The Chairman informed the public of the posting of the open meeting laws.

The Affidavits of Publication were presented. The meeting notice was published in the Columbus Telegram on June 29, 2021 and the Humphrey Democrat on June 30, 2021.

Chairman Micek stated that the agenda be approved as written.

Voting Ayes: Supervisors Lloyd, Scow, Liss, Engdahl, Kwapnioski, Pfeifer and Chairman Micek.

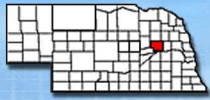

Supervisor Kwapnioski reported the Finance Committee had a meeting with the department heads on June 30 and told them what our expectations were and set parameters looking at the bigger purchases, it was a good session. Supervisor Micek asked the following if you would agree, Jerry Engdahl, Fred Liss and Kim Kwapnioski to review the money that supposedly the county is supposed to get for federal aid. I would like you three to review and see exactly what we can do and come back with recommendations of what we can just do and then the board as a whole can sit down and decide whether or not we can do some of those things. Would all three of you be willing to do that? They all agreed. Kim asked if you wanted ideas or recommendations from the county? She also stated more information should be coming mid-July. Supervisor Micek stated you three are to come back with what we can do and what we can't do.

Voting Ayes: Supervisors Lloyd, Scow, Liss, Engdahl, Kwapnioski, Pfeifer and Chairman Micek

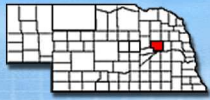
