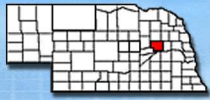

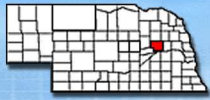

Committee Reports: Supervisor Liss reported he has an extension club meeting next week, he participated in a conference call with the State of Nebraska Department of Roads with our engineer on E 29<sup>th</sup> Avenue. Supervisor Kwapnioski reached out to Jon Cannon at NACO in regards to the federal money that is coming in and Jerry Engdahl talked a little about that. He sent me more information and he told me that counties are moving ahead and looking at what projects they want to do. We can run anything past NACO to see if it will be paid or not. It would be my recommendation we run things past NACO. We have a committee working on some of those projects or whatever we are looking at. Supervisor Engdahl reported the building and grounds committee was contacted by Kurt Shevlin, he said he is having a hard time finding employees, so he is asking for more money. He asked Supervisor Micek if he knew anything about the front step. Supervisor Micek stated the South Dakota firm and precast people are working together on this. Supervisor Pfeifer reported there will be a budget workshop on August 17, 2021 at 1:00 pm. Supervisor Kwapnioski stated to adopt the proposed budget on 9/14/2021 that's the timeline. Supervisor Scow reported the joint committee is meeting on an annual basis on trying to keep a full staff with those people. Supervisor Micek reported on the fire situation out at ADM and how the residents were not properly notified of the issue.

Public Comments: Arnie Stuthman, I am going to thank Jane for her report today. She cleared up a lot of the things I was concerned with, with bids and Christ Lutheran Church. The one thing that bothers me is the county employees doing bridges, like she said you know I think they should be contracted out to people who specialized in doing bridges. Because of the fact that a lot of the employees don't know and do not have the knowledge to do bridges. It was kind of hard for me because when going to Colfax County we travel that road all the time and we have to travel eight miles to get two miles on that road. She stated that hopefully the bridge will be opened on September 1<sup>st</sup>. I was hoping for setting a time of September 10<sup>th</sup> and that's when there's going to be a lot of trucks hauling grain as other people who

live on that road. My biggest issue is an observation, I think we could do a lot better job of building and replacing bridges if we can contract them out if we can get a good contractor.
