PROCEEDINGS OF THE PLATTE COUNTY BOARD OF SUPERVISORS

Columbus, Nebraska August 31, 2021 Tuesday, A.M.

Pursuant to adjournment the Platte County Board of Supervisors met for a Special Meeting beginning at 9:00 a.m.

Roll Call and the following members present: Supervisors Liss, Kwapnioski, Pfeifer, Lloyd, Scow and Chairman Micek

Absent: Supervisor Engdahl

The Chairman informed the public of the posting of the open meeting laws.
