

PROCEEDINGS OF THE PLATTE COUNTY BOARD OF SUPERVISORS

Columbus, Nebraska May 10, 2022 Tuesday, A.M.

Pursuant to adjournment the Platte County Board of Supervisors met in session beginning at 9:00 a.m. Jennifer E. Brown County Clerk, Gerald B. Micek, Chairman.

Roll Call and the following members present: Supervisors Liss, Engdahl, Kwapnioski, Pfeifer, Lloyd, Scow and Chairman Micek

The Chairman informed the public of the posting of the open meeting laws.

The Affidavits of Publication were presented. The meeting notice was published in the

Columbus Telegram on May 3, 2022 and the Humphrey Democrat on May 4, 2022.

Chairman Micek stated that the agenda be approved as written.

Chairman Micek stated that the minutes for April 26, 2022 be approved as written

Katie Bargman presented a statement of opposition to Heartland Greenway Pipeline and Summit Carbon Solutions.

Carrie Rodriguez and Jeff Banholzer, District 5 Probation gave a department update.

Motion, Supervisor Engdahl seconded Supervisor Kwapnioski, to approve the funding request of \$61,776.50 for the 2022-2023 fiscal year for District 5 Probation, and vote was as follows:

Voting Ayes: Pfeifer, Lloyd, Scow, Liss, Engdahl, Kwapnioski and Chairman Micek Voting Nays: None


Whereupon the Chairman declared the motion carried.
