RESOLUTION NO. 23-30

INTERLOCAL AGREEMENT Highways 30 TO 64 Corridor

THIS AGREEMENT, made and entered into, as of the dates indicated below, by and between Platte County, City of Columbus Nebraska, Colfax County, Polk County and Butler County (hereinafter referred to as Platte, Columbus, Colfax, Polk, and Butler respectively); all parties are public agencies of the State of Nebraska within the definition of Neb. Rev. Stat. 13-803(2).

WHEREAS, THE State of Nebraska under Neb. Rev. Stat. Section 13-801 et. Seq. the Interlocal Cooperation Act allows interlocal agreements between governmental entities to perform joint planning, construct improvement projects and share resources including funding for said projects.

WHEREAS, A Traffic Study was completed, showing that Highways 30 and 64 carry large volumes of traffic, including heavy truck traffic and when mixed with passenger traffic poses a potential for accidents and bottleneck along the respective corridors; and

WHEREAS, Nebraska State Highway 30 AND 64 ARE MAJOR ARTERIALS SERVICE Platte, Columbus, Colfax, Polk and Butler and their respective industries and a Benefit/Cost Study has shown the project to be beneficial to all parties; and

WHEREAS, the Platte River crossing on Highway 30/81 is the only river crossing within fifteen (15) miles that serves the regional area; and

WHEREAS, the flood of 2019 caused significant economic loss and hardship to Platte, Columbus, Colax, Polk and Butler due to limited access; and

NOW, THEREFORE, IT IS AGREEMENT AMONG THE PARTIES AS FOLLOWS;

- 1. THAT Platte, Columbus Colfax, Polk and Butler agree that a regional Planning Study of the corridor connecting Nebraska State Highways 30 and 64 and other roadways in the four-county region is the next step of engineering analysis, environmental assessment, and other elements to move the project forward.
- 2. THAT by concurring in the need for a regional Planning Study as indicated in Section 1 above, the parties express their desire to pool efforts to accomplish the same and to seek assistance from the Nebraska Department of Transportation, Federal Highway Administration and the North East Nebraska Economic Development District (NENEDD).
- 3. THAT Platte will serve as the lead agency for the purpose of engaging NENEDD for assistance in securing grant funds to cover the cost of the Planning Study.
- 4. THAT these parties agree to establish the Highway 30/64 Advisory Board and each party will designate a representative to serve on the Advisory Board to participate in and share information from the respective party as the grant-writing process is underway. The members of the Advisory Board agree to serve without compensation from the funds pledged for the project.
- 5. THAT the Advisory Board will conduct open meetings as needed in locations to be determined to allow for public input into the possible highway and corridor improvements and potential river crossing. The Secretary/Treasurer will advise the board members of the date, time, and location of all meetings by email or other method as may be requested by each board member.
- 6. THAT Platte County as the lead agency will designate a Chairman for the Advisory Board. The Chairman will be responsible for scheduling and conducting meetings as needed and for signing any official correspondence from the board.
- 7. THAT the Advisory Board will designate a Secretary/Treasurer to be responsible for the recording and distribution of meeting minutes, to process correspondence, to process any invoices and to taract any contributions of each of the parties.

- 8. THAT following the application for grant funds to cover the cost of the Planning Study, the amount of funds secured will be presented for review and consideration by the parties for further action. This agreement does not imply or require participation of any of the parties in proceeding with the Planning Study.
- 9. THAT this agreement will be in effect as of the dates on which the parties have expressed their intention to participate. Following conclusion and reporting of the amount of grant funds secured the parties will have the opportunity to determine their continued participation in this project.
- 10.THAT any party may terminate this agreement with or without cause. Any party wishing not to continue its participation to the conclusion of the Planning Study will provide advance written notice of the same to the other participants not less than thirty (30) days prior to its original intended participation ceasing date.
- 11.THAT as of the effective date of this agreement, each party represents and warrants to the others that the execution and performance by it of this agreement has been duly authorized by all necessary corporate or subdivision action and constitutes its valid and legally binding obligation and is legally enforceable as such by the other parties.
- 12.THAT this agreement shall be binding upon and inure to the benefit of the parties hereto, and their heirs, executors, administrators, successors and assigns of the respective parties.
- 13. THAT no waiver by any party to this agreement of any default or breach of this agreement shall operate as a waiver of any other default or of the same default on a future occasion.
- 14.THAT if any term covenant of condition of this agreement or the application thereof to any person or event will to the extent be invalid or unenforceable, the remainder of this agreement in the application of such term, covenant or condition to persons or events other than to those to which it is held invalid or unenforceable will not be affected thereby and each term, covenant or condition of this agreement valid and enforced to the fullest extent permitted by law.
- 15.THAT this agreement contains the entire understandings of the parties. There are no representations, warranties, promises, covenants or understanding other that those expressly set forth herein.
